Application in the prescribed proforma are invited from Civil Engineers retired in the rank of Executive Engineer (R & B) with the following stipulations for empanelment with Odisha Real Estate Regulatory Authority, Bhubaneswar to undertake field inspection as when required by the Authority for cities such as Bhubaneswar, Cuttack, Berhampur, Balasore, Sambalpur, Rourkela and other notified areas.

1. He/ She should not have completed 62 years of age as on the date of application.
2. He/She should possess a Bachelor's degree or equivalent from an institution recognized by the All India Council of Technical Education or any University or any institution recognized under a law or is registered as an Engineer under any law for the time being in force.
3. He/She must have good service records and should not have vigilance or criminal case pending against him/ her.
4. He/ She should be in sound health and capable of undertaking field assignments.
5. The empanelment shall be made for a period of one year initially, which may be extended for a further period basing on his/her performance and requirement of the Authority.
6. The Empaneled Engineers shall be paid a professional fee of ₹3000/- (Rupees three thousand) per day and Daily Allowance of ₹400/- (Rupees four hundred) per day when deployed outside the headquarters, as and when engaged.
